Election of Working Groups 2015/16

- I Councillors have identified preferences for the Working Groups for 2015/16 in accordance with Standing Order 15. These are attached at Annex I, in order of preference for each Working Group as indicated by each councillor. Some councillors expressed a preference for only the Working Groups for which they were interested whilst others have given a priority listing for all the Working Groups. Standing Order 15 (e) states that the overall membership of the Working Groups will reflect as closely as possible the political make-up of the Council with the intention that as broad a range of councillors as possible is represented. By convention the Mayor is not appointed to Working Groups, and can attend any Group ex-officio.
- There are four Working Groups plus one Standing Task Group (HR Panel) and the Planning and Licensing Consultative Group. Standing Order 15 f suggests (not mandatory) how places are to be allocated to ensure that those who are not members of the majority group are fairly represented. As such, with 6 out of 18 councillors, the 'minority' representatives should have two places on Strategy and Finance out of a total allocation of 8 places overall between the Working Groups. With six places available on each Working Group two of these places would be available to councillors who were not part of the majority group, if they wished to be part of the Working Group.
- As a result of the preference exercise, there was most interest in being part of the Strategy & Finance Working Group. I I councillors expressed an interest. Four majority Group Councillors expressed a first preference along with one first preference from other councillors. As a result these five councillors would be deemed to be elected (assuming Council follows Farnham's previous practice of appointments to Working Groups) with a vote to be taken on the remaining place from among the four councillors who are not part of the majority Group.
- 4 In relation to the remaining Working Groups the following expressions of interest were received.
 - Community Enhancement Working Group –Eight preferences for six places: seven from the majority group and one other. As such, the five councillors including a first to third preference would be deemed appointed with one additional place available to the minority councillors (or Councillor Cockburn if none were interested).
 - Planning & Licensing Consultative Group Nine councillors have expressed a
 preference for the nine places available. The aim is, if possible, to have one
 councillor from each ward. Both councillors in the Castle Ward and the Shortheath
 and Boundstone Ward have expressed a wish to be on the Planning & Licensing
 Consultative Group but there has been no preference expressed from the

Wrecclesham & Rowledge or Firgrove Wards. Council may wish to appoint the nine councillors who have expressed a preference to be on the Working Group or elect one councillor per ward.

- Cemeteries and Appeals Working Group Seven preferences for six places
 including one preference from the 'minority' councillors. As such four councillors
 would be deemed to be elected, with one place available to a 'minority' councillor,
 and one place for the three majority group councillors expressing a third preference
 for this Working Group.
- Tourism and Events Working Group Eight preferences for six places, including one 'minority' councillor. As such five councillors are deemed to be elected with one remaining place for the 'minority' councillors or if there were no interest a vote would be taken between Councillor Ward and Councillor Hargreaves.
- HR Panel Six preferences for six places. All would be deemed to be elected

The Candidates for each of the above Working Groups are deemed to be elected as set out above. Councillors are invited to opt or nominate for the remaining places. If there are more candidates than places available an election will take place for the vacant places only.

- As in previous years, it is proposed that Council is adjourned briefly so that each Working Group can elect its Lead Member to confirm the composition of the Strategy & Finance Working Group.
- 6 Council needs to confirm whether its Task Groups are to be reconvened. The HR Panel (technically a Task Group of Strategy and Finance) is expected to continue whilst the remaining Task Groups needs formal agreement to be re-established. The HR panel has six councillors expressing a wish to fill the six places available.
- Subject to Council's decision on Task Groups, the appointment to Task Groups will need to be agreed. In accordance with Standing Order 15 (f) membership of task groups does not need to conform to the political make-up of the council.
- Subject to the decision on paragraph 7, the Health Task Group has insufficient members; the Infrastructure Planning Group has nine councillors offering to fill five places, and the Offices Task Group has four members for the three places. Council could amend the size of Task Groups if it wishes to.

Recommendation

It is recommended that

- a ballot takes place for the remaining the Strategy and Finance Working Group as set out at paragraph 3;
- 2) the candidates for the Cemeteries and Appeals, Community Enhancement and Tourism and Events working groups be appointed as set out in Annex I along with any additional councillors to fill the remaining vacancies as set out in paragraph 4 above;I
- 3) Council determines if all nine councillors wishing to be on the Planning and Licensing Consultative Group be appointed;
- 4) the Working Groups elect their Lead Members (in order to do which the meeting be adjourned briefly) in order to confirm the complement of Strategy and Finance Working Group Members
- 5) Council determines which Task Groups be reappointed and the membership of each Task Group.

NMA/2015/0039 Brightwell, East Street, Farnham

Amendments to application NMA/2015/0039, following consideration at Full Council in April 2015

a) Introduction

The Town Council objected to NMA/2015/0039 in April 2015, following discussion at Council. A copy of this objection is attached at Annex I to this report. The application at this time was to amend condition 16 of the 2012 planning application as follows:

"16. The proposed road and vehicular access to the A31 Farnham Bypass, including the temporary vehicular bridge over Borelli Walk and the River Wey, shall be designed and constructed prior to the implementation of WA/2012/0912, with the exception of the works identified in schedule 16032-SC-006, unless otherwise first agreed in writing by the Local Planning Authority. No development shall begin, with the exception of the works identified in schedule 16032-SC-006, before that junction, the bridge, access road and site compound have been completed broadly in accordance with the application drawings and the requirements of the County Highway Authority. Once constructed the access and bridge shall be retained free of any obstruction to its use in accordance with a duration to be agreed in writing with the Local Planning Authority.

Copies of the initial plans are attached at Annex 2(i) and 2(ii).

b) Changes to the application

Further to objections, Crest Nicholson have proposed the following changes and the amended application now seeks the following revisions to condition 16:

"16. The proposed road and vehicular access to the A31 Farnham Bypass, including the temporary vehicular bridge over Borelli Walk and the River Wey, shall be designed and constructed prior to the implementation of WA/2012/0912, with the exception of the works identified in schedule 16032-SC-006_B, unless otherwise first agreed in writing by the Local Planning Authority. No development shall begin, with the exception of the works identified in schedule 16032-SC-006_B, before that junction, the bridge, access road and site compound have been completed broadly in accordance with the application drawings and the requirements of the County Highway Authority. Once constructed the access and bridge shall be retained free of any obstruction to its use in accordance with a duration to be agreed in writing with the Local Planning Authority.

Copies of the amended plans are attached at Annex 3(i) and 3(ii).

The notable change is to the schedule of works proposed to be completed prior to construction of the bridge. This has changed from:

- 5) Demolition of the Redgrave Theatre
- 6) Sewage diversions
- 7) Utility diversions
- 8) Construction Access Bridge
- 9) Site set up

- 1) Provision and collection of welfare facilities
- 2) Demolition of tennis club pavilion.

c) Issues for consideration by Council - May 2015

i. Materiality of revised changes

To consider if the changes as proposed are non-material.

ii. Validity of Application in respect of land ownership

Applications for non-material amendments may only be made by the freeholder of the land in questions, or by a person with an interest in the land. Consideration may be given as to whether CN has a legal interest in the land, whilst the lease from WBC has not commenced.

iii. Impact of the lack of bridge

To consider the effect on not having the construction bridge during the time of the works proposed on:

- a. Traffic
- b. Pedestrian safety

It is recommended that:

- Members note the initial objection submitted to Waverley BC in respect of the detail of the application in April 2015.
- 2) Members consider any amendments or additions to the objections, following receipt of the changes made to the NMA detailed in this report.
