LOCATION AND EXTENT OF GOSTREY MEADOW

Gostrey Meadow is an attractive open plan park that links Farnham Maltings and the River Wey to Farnham Town Centre.

EXECUTIVE SUMMARY

Gostrey Meadow is a fantastic community resource, highly valued by local residents.

Farnham Town Council took over the management of Gostrey Meadow from Waverley Borough Council in autumn 2019.

This management plan seeks to ensure the quality of maintenance is upheld and continual improvements are delivered year on year so Gostrey Meadow continues to provide local residents with a high quality open space in the centre of the town.

Gostrey Meadow provides a significant events space for the local community and is used throughout the year for events such as the Farnham Sustainability Festival along with other long standing Town events including the Rotary Club Duck Race in May and the series of Music in the Meadow events from June to early September as well as Farnham Carnival; the Remembrance Sunday service, the Allotment Show and Christmas Lights Switch-On. The site also provides less obvious environmental benefits such as flood mitigation all of which need to be managed together.

Fundamentally the plan seeks to ensure that management achieves the required standards of maintenance, that effective repairs are made and that materials utilised are sympathetic to the park and town's landscape character.

To achieve this aim, the plan will highlight essential details such as choice of plants, furniture, types of surfacing, paint colours, signage etc.

FOREWORD

The Community Enhancement Working Group works with council officers on the improvement and development of allotments, gardens, open spaces, street furniture and other public spaces

I am proud to endorse this management plan as a guide for the future development of Gostrey Meadow reflecting the high standards of management and maintenance practices that the council strives to achieve.

The landscape and green spaces are an important part of town life. Management of the council's parks and green spaces across the town endeavour to ensure that these vital green spaces provide for our residents.

Gostrey Meadow is an excellent example of one of Farnham Town Council's green spaces that has some great public facilities. This urban park is close to the town centre and has been developed to offer the town's residents a great space for community events as well as encouraging a place for passive recreation, picnicking and walks along the River Wey.

The park has three distinct areas with the more formal amenity planting areas near the War Memorial and play area as well as the more informal conservation area along the banks of the River Wey, supporting the general park uses.

1.0 INTRODUCTION

1.1 Background to the plan

The importance of parks and open spaces in an urban environment was recognised by the Victorians in the late 19th Century; this is as true of Gostrey Meadow as anywhere else.

Public parks were created to enhance the health and wellbeing of the population and to give opportunities to socialise, thus enhancing the community spirit. It is perhaps not so surprising that today the value of parks are recognised for those self-same reasons. Despite this importance, Gostrey Meadow, like so many others, had been allowed to decline during the 1980s and '90s.

Farnham Town Council took over the management of Gostrey Meadow from Waverley Borough Council in autumn 2019 and is committed to using the Green Flag Award Standard as a benchmark to ensure continued improvement to this significant community asset for Farnham year on year.

2021 will be the first Green Flag application for Farnham Town Council: however Gostrey Meadow won a Gold award at the South and South East in Bloom Awards in 2020. It has also been an integral part of the judging for the Town Centre category

for South and South East in Bloom and RHS Britain in Bloom. In 2019, Farnham Town Council won Gold in the RHS Britain in Bloom Awards and was also a Category winner.

1.2 Purpose of the plan

The vision for this plan is to protect and further enhance the park and conserve its amenity and open space significance to the town

Specifically:

- The plan will ensure continuity of approach and ensure that its design, materials and landscape remain consistent to ensure the site continues to reflect the distinct landscape character of Farnham town.
- The plan is a working document, acting as a reference point for all future management.
- The plan will be reviewed annually to include new information and amended management practices adopted.
- The plan will provide policies for management and a maintenance schedule which will be summarised at the end of the document.
- The plan and associated action plan will feed into Farnham Town Council's applications for Community Infrastructure Levy (CIL) for any future park development.

1.3 The Green Flag standard

The Green Flag Award is the benchmark national standard for publicly accessible parks and green space in the United Kingdom and now internationally.

The scheme was established in 1996 to recognise and reward green space in England and Wales that met the laid down high standards

Farnham Town Council will adopt The Green Flag Award Judging Criteria to guide the future management and maintenance prescription for Gostrey Meadow, and if successful look to roll out to other parks and open spaces within Farnham.



RHS Britain in Bloom Awards 2019

The criteria for the Green Flag Award aligns with the council's approach to its management and policies for parks and open spaces, which forms the basis for future management.

Green Flag Judges' recommendations will be considered as part of the annual review of this plan with council staff, members, volunteers and the wider community.

I.4 Generic Management approach policies for the town's parks

- Wider and better access for all and improved community cohesion.
- Enhancing existing green space rather than providing more.
- Providing a safe network of green links between the strategic green spaces.
- Providing safer access to and within the park.
- Providing better promotion in support of the town's regeneration and tourism commitment to maintaining the restored features and zero tolerance of anti-social behaviour, such as graffiti
- Promotion of biodiversity and people's understanding of it.
- Helping the community towards a healthier lifestyle.
- To strive for more sustainable management techniques and focus on the environmental agenda, (such as climate change).
- To further effective marketing of Gostrey Meadow to attract and inform users.

These top line objectives are underpinned by detailed policies and are referenced in **Appendix I Farnham Neighbourhood Plan 2013-2032 (Updated March 2020)**

I.5 Summary Statement: Gostrey Meadow - aims and objectives

The aim of Farnham Town Council's overall management is to ensure that the character and overall landscape quality of the town park are further enhanced.

The plan demonstrates how Gostrey Meadow already contributes to the Council's corporate objectives and provides the basis to further increase the value of the park to the community since taking over the management from Waverley Borough Council in November 2019 by:

- Ensuring easy access to all.
- Providing good signage/information.
- Improving educational activities.
- Controlling unacceptable behaviour.
- Making the park safe and clean.

Our objectives are to:

- Maintain a high standard of horticultural and arboricultural practice.
- Continue involving the community in decisions about the ongoing management of the park.
- Maintain all buildings, structures and facilities in a good state of internal/external repair.
- Ensure all vandalism/graffiti is dealt with quickly.
- Make the park a safe and enjoyable place to be.



1.6 About the park

Gostrey Meadow was originally part of an 11 acre estate owned by The Bush Hotel. Over the years the estate was broken up and used as a wasteland and rubbish dump. After much work and generous offers of trees and plants by the community, Gostrey Meadow was officially opened in 1910.

Today Gostrey Meadow provides a diverse range of green space ranging from formal areas of amenity landscape nearer to the War Memorial, to the more natural landscapes along the banks of the River Wey. Gostrey Meadow is central to Farnham and hence is a focal space for community gatherings and provides the backdrop for much of the town's major annual programme of events.

1.7 Management prescriptions – significance and core aims

Farnham Town Council's Business and Facilities Manager is responsible for the overall management of Gostrey Meadow.

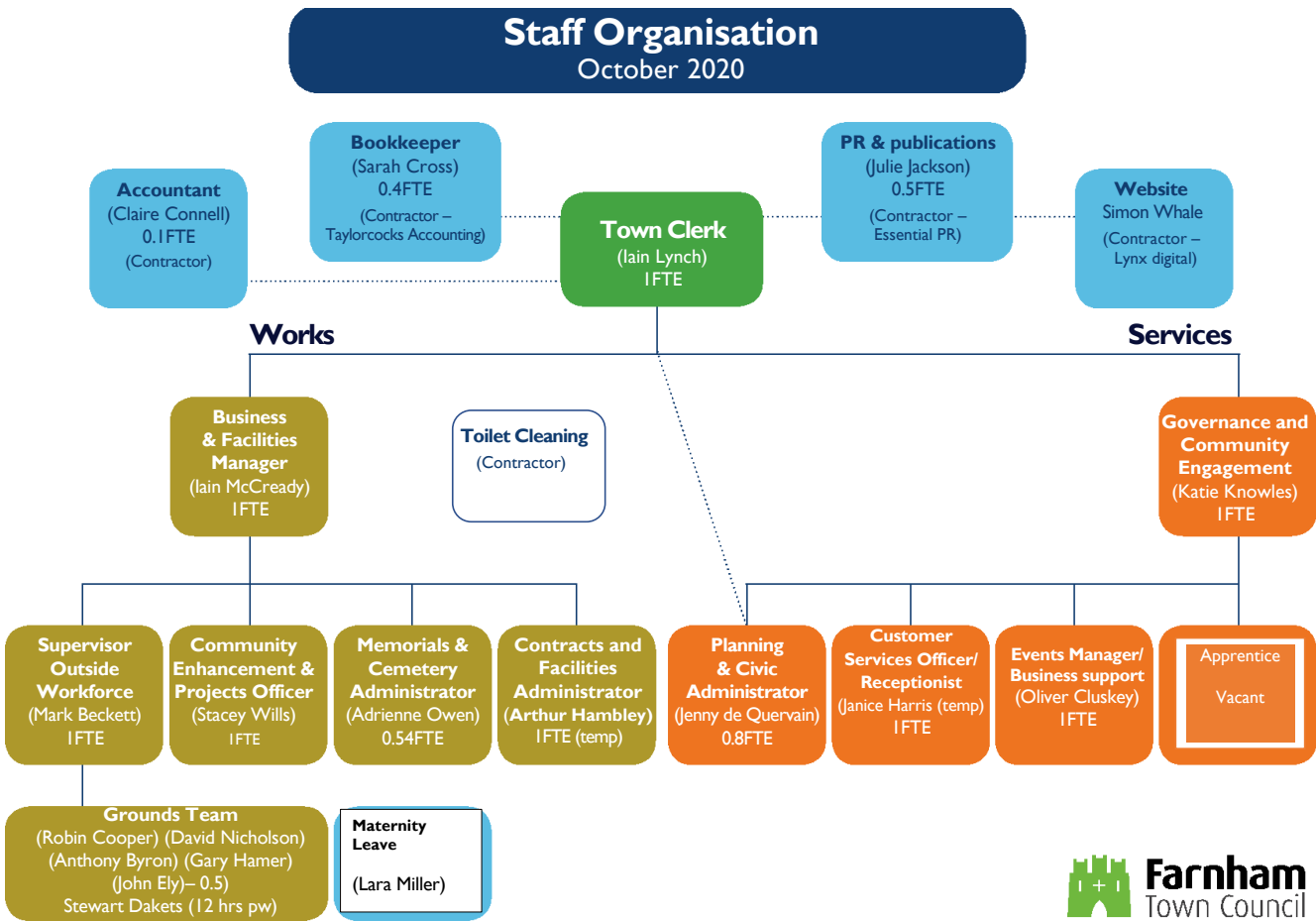
A team of ten staff make up the core parks team who provide a cohesive park's management service, all of whom will adopt this plan as a guide to future management of Gostrey Meadow.

SECTION 2

2.0 PEOPLE AND GOSTREY MEADOW

Gostrey Meadow is central to Farnham town and as such is a special community park that is the hub for many Farnham Town Council events and visited by thousands of people over the course of each year.

Due to Gostrey Meadow's importance to Farnham, the council saw it as the flagship park with which to seek its first Green Flag Award - the national recognised benchmark for parks excellence.

The Green Flag Awards judging criteria will be used by the Farnham Town Council parks team to support the future management and maintenance of Gostrey Meadow and ensure the park meets the growing demands of the town's growing population.

The below extract is from Farnham Town Council's submission to South and South East In Bloom Award in 2020. This brochure shows the importance Gostrey Meadow already plays in town life.



Horticulture

Farnham Town Council took over the management of Gostrey Meadow from Waverley Borough Council in autumn 2019.

The focus for this year has been clearing some of the older shrubs including Carex, Humulus and Euphorbia. Himalayan balsam has previously been removed and successfully treated. Problem grass areas have been addressed. There has been extensive work on the rose beds which has included pruning, planting of new rose plants and improving the soil. The soil is improved by using compost from the nursery which has been recycled from hanging baskets and the use of soil conditioner from our sponsor Continental. This soil improver is recycled green waste. This year, the theme for the carpet bed was VE Day to mark the 75th Anniversary in May. Before this bed was planted the framework was rebuilt.

Normal grass cutting and maintenance continued during the lockdown period. Outside work force teams were placed in 'bubbles' of two workers so that social distancing measures could be observed. PPE and increased hygiene procedures have been strictly followed.

A local community group has planted courgette plants in a bed. The courgette flowers create interest and users of the space will be encouraged to pick the courgettes when they are ready. Lavender plants have been added to the area and provide a splash of colour and fragrance and create an ideal habitat for bees and other insects.

Large sections of the riverside have been cleared of many overgrown plants and shrubs to allow better sightlines and to open up access for families and children to enjoy the water on a summer's day.

Environment

Plans have been drawn up to develop the old bowling green site to create a community café and hub and potentially re-site the play area. These plans have had to be put on hold due to the Coronavirus situation.

There has been a continued programme of refurbishment of waste bins in the park. There are plans to replace gates on the main entrance on the Union Road side and a local charity, The Farnham Lions, have offered to contribute to the cost of these. This project has been put on hold until later this year.

Litter and graffiti problems have been acted on quickly and resolved.

Peat free compost has been used in the beds, garden waste is composted and river water is used to water the flower beds and planters. Alongside the VE Day carpet bed, VE day themed bunting was put up in the park.

A large area of the riverbank which was previously neglected has been cleared and sown with wildflower seed which will add much needed colour to the area as well as attracting bees and birds.

Community Participation

Although 20 events had to be postponed or scaled back due to Covid19 in 2020, Farnham Town Council staff continued to ensure Gostrey Meadow was safe for daily exercise and plenty of great plans for 2021

These had to be cancelled due to the Coronavirus situation. To facilitate these events, a project had been started to provide better electricity supply for music, lighting and sound.

This will be in place before the new events programme is relaunched in August within Covid-19 guidelines.

In previous years, the Bloomin' Friends volunteers would have supported the outside works team with dead heading, weeding and watering. This group are mostly aged over 70 or shielding but as restrictions lift, they have started to help around the park and plant some planters. The volunteers will also be creating flower beds around the bandstand to add much needed colour.

The park has been well used by individuals and families for their daily exercise and as the lockdown restrictions have been eased, particularly in the warm weather, the park has been busy with people enjoying a picnic or children playing in the river.

In line with government restrictions, the playground was closed to the public but has reopened.

2.1 ENSURING GOOD ACCESS FOR ALL

Farnham town has an ageing population. The population of Farnham as a whole, is older than the national average. The council's equalities policy aims to ensure fair and equal access to all council services.

The council promotes community cohesion providing opportunities for all community groups to utilise open space.

The park is fully inclusive, offering free access opportunities for the whole community. It offers members of the community a chance to join together and interact in a positive and enjoyable way.

Much of Gostrey Meadow is accessible, (although full accessibility for wheelchair users and those with mobility impairment may not be possible due to the topography of the site).



2.1.1 Getting to the park (public transport)

Gostrey Meadow is located centrally within the town of Farnham meaning it is easily accessible on foot or via public transport.

Located a few minutes walk from Farnham town centre and Farnham Station, most park visits are made by foot or via public transport.



Train Farnham Station: Gostrey Meadow is a 3 minute walk from Farnham Station across the Farnham Bypass.



Bus Routes: The following bus routes 4 5 16 17 18 19 and 46 alight on the Union Road perimeter of Gostrey Meadow.



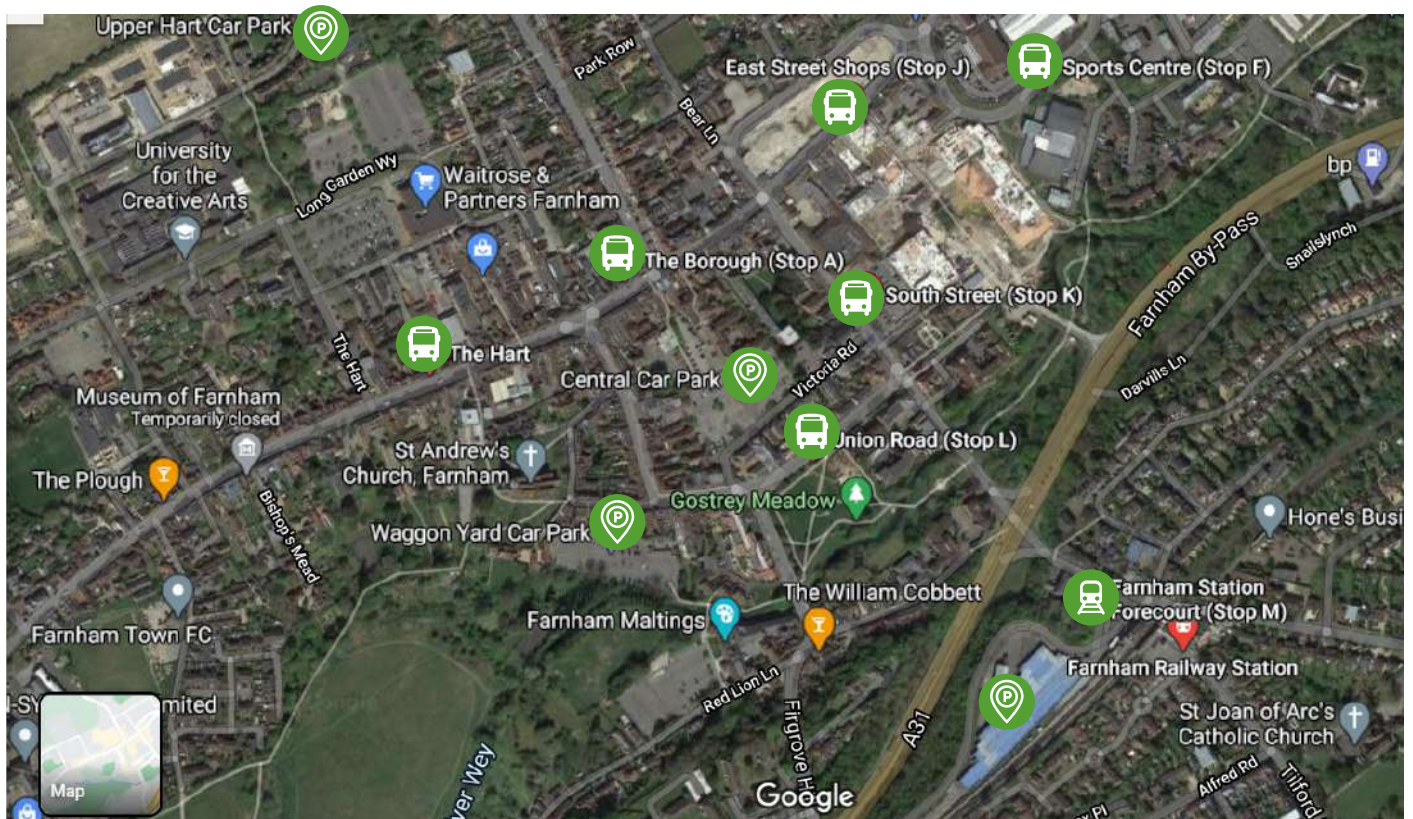
Walking: There are eight pedestrian entrances to Gostrey Meadow South Street, Union Road, Long Bridge and Abbey Street



Cycle Parking: There is currently no off street cycle parking within Gostrey Meadow, but there is nearby at the Town Hall. Cyclists are also able to lock up bikes to the playground fence.



Car Park: There is on street parking close to Gostrey Meadow at Long bridge and there are four pay and display car parks in Farnham town that can be used.



The park is situated with good public transport links from the town centre

2.1.2 Car parking and provision for people with disabilities

Currently there is free parking in Farnham on Sundays in close proximity to Gostrey Meadow. Central Car Park offers disabled parking and also nearby Farnham Town Council car park which is 400m from Gostrey Meadow.

Safe road crossings are available at the junction of Union Road and Long Bridge, linking adjacent residential areas with Gostrey Meadow. Currently there is no formal road crossing on South Street to join Borelli Walk and Gostrey Meadow.

2.1.3 Access into and within the park

Good access is one of Gostrey Meadow's key strengths. Although some ramps into the park are steeper than the recommended 12:1 gradient, many accessible entrances exist. Where full Disability Access Obligations (DDA) compliance cannot be achieved, then the least most restrictive option is provided. Farnham Town Council will continue to take reasonable steps to ensure access is improved

wherever possible.

For users with restricted mobility there are several access points which lend themselves to easier access; the map below details these.

In general, the path network throughout the park is sound and appropriate for its purpose and the bridge across the River Wey has a sympathetic gradient.

2.1.4 Limiting vehicular movement in the park

Farnham Town Council and contractor vehicles access the park through the Union Road access as do vehicles involved in events. Where possible the vehicles use existing paths, although these will be strengthened in future. Vehicular access to the War Memorial site is generally restricted.

2.1.5 Farnham Town Council sustainable transport policy

As part of the Farnham Infrastructure programme, Farnham Town Council is working with Surrey County Council and Waverley Borough Council on a range of active travel measures. The Farnham Cycling Forum is also involved in these discussions. The proposals are out to initial consultation from 15th February until 14th March. The Infrastructure Programme is looking to make significant changes over the next 15 years and encourage more sustainable ways for how people can move around Farnham.

2.1.6 Disability Discrimination Act – DDA/Disability equalities duty

An audit of the parks facilities and buildings was carried out in Winter 2019 prior to Gostrey Meadow's handover from Waverley Borough Council. Costing for access and facilities improvements have been submitted by Farnham Town Council for community infrastructure levy (CIL) funding consideration.

An audit of the park's infrastructure and access points was carried out (winter 2020) linked to Green Flag Management Plan preparation and all necessary access improvements will be submitted for CIL funding consideration.

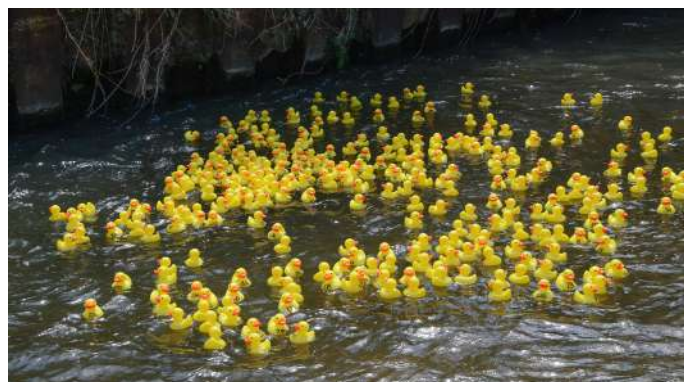
The Council has a Wellbeing Health Task Group. A key element of the duty requires the Council to involve disabled people when formulating policy and determining actions.



2.2 COMMUNITY COHESION – “SENSE OF PLACE”

Gostrey Meadow offers opportunities to relax, walk the dog, take children to the playground, have a picnic with friends, or listen to music from the bandstand. In particular it acts as a major catalyst in bringing communities together.

A variety of events/activities are organised, to cater for varied tastes and aiming to attract those who might otherwise not use the park.





2.2.1 Farnham Town Council Green Flag and Community Enhancement Working Group



The Community Enhancement Working Group is made up of councillors and officers and meets five times a year to discuss Farnham's green spaces and particularly Farnham in Bloom. In addition to this there is a Farnham in Bloom Community Group which meets regularly to discuss projects and volunteering opportunities. This group is made up of volunteers and overseen by an officer.

Since taking over Gostrey Meadow, a subgroup called Friends of Gostrey Meadow has been set up to specifically look at projects in Gostrey Meadow. This is made up of volunteers, local businesses and other community groups that have an interest.

Supported by the Town Council these groups have the following aims:

- Undertake fundraising for key projects in conjunction with the council and other partners.
- Encourage activities that promote/improve the park.
- Promote of interpretational and educational activities.
- Oversee the care of the tree collection and seeking to expand the range of trees planted.

The Community Enhancement and Projects Officer is the key facilitator between the group and Farnham Town Council.

2.2.4 Cultural heritage

Farnham has a magnificent history: Stone Age, Roman and Saxon dwellings have been found in Farnham. England's first cistercian monastery Waverley Abbey was built near Farnham.

History of Gostrey Meadow

Gostrey Meadow has a diverse history and is mentioned in Elfrida Manning's Saxon Farnham and is shown on the map as 'Gostrode'. It is thought that Stoud or Strode means marsh and Gos means goose.

Nigel Temple's Farnham Buildings and People mentions that are thought to be two meadows originally owned by The Bush Hotel and it was known as Gostreeds.

In 1908, according to Edwardian Farnham by W, Ewbank-Smith it states that "The Councillors themselves, however, had set their hearts on two acres of land off Union Road belonging to the Rev. M.O Stevens, called Gostrey Meadow, and an adjoining one acre, which fronted South Street, belonging to Mr Bide".

The land was poor quality and had been used as a wasteland and rubbish dump. A great deal of clearing had to be done first and "Gifts were already pouring in from well-wishers. Mr Patterson had promised a sum of £21 to be spent on a drinking fountain to the design of Harold Falkner; Mr W.H Allen and Sam Bide gave trees"

Gostrey Meadow was officially opened to the public on 10 October 1910. The addition of the bowling green was added shortly after. Mr Borelli presented a shelter in 1912 which still stands today.

The War Memorial in Gostrey Meadow was designed by architect W.C. Watson and constructed by local stonemasons Patrick's by the South Street entrance. £900 was raised by public subscription. The memorial is 23 feet high constructed in Portland stone in a hexagonal configuration. The Memorial was unveiled on 10 April 1921. The dedication of the panels and the unveiling of the names of those who died in the Second World War was undertaken by the Lord Lieutenant of Surrey and the Bishop of Guildford on 8 July 1951.

Waverley Borough Council owned and managed Gostrey Meadow before Farnham Town Council took over in 2019, although the Town Council had constructed the bandstand and had already taken

on responsibility for the public toilets and the War Memorial.

2.3 IMPROVING EDUCATIONAL AND HEALTHY ACTIVITY

2.3.1 Education

Owing to its town centre location schools and colleges often organise field trips to support children's development and education. The new National Curriculum includes "Education for Sustainable Development" (ESD). A key aim within this is to promote awareness, understanding and respect for the environment in which we live. It also sets out to secure commitment towards sustainable development at a personal, local, national, and global level.

Gostrey Meadow can offer huge opportunities in helping children understand both the natural and landscaped environment and the importance of protecting it for future generations.

The Community Enhancement and Project Officer works closely with Farnham In Bloom volunteers and wider community stakeholders to offer sessions to local schools and community groups. These sessions involve anything from bulb planting to litter picking. Farnham's events programme that takes place in Gostrey Meadow offers schools and drama/music groups the chance to perform in events such as the Christmas Light Switch-On.

2.3.3 Events in Gostrey Meadow 2021-22

Traditionally Gostrey Meadow is used for the following events throughout the year:

Sustainability Festival – This event launches the programme of activities for the year. With live music, talks, local food and drink and kids' fun, this event is organised in partnership with Farnham Community Farm and focusses on sustainability, community and well-being.

Duck Race - The annual Duck Race is held on the River Wey adjacent to Gostrey Meadow. Races are held approximately every 20 minutes. There are also a number of stalls run by local charities. This event is organised by the Weyside Rotary.

Farnham Carnival – Organised by the Farnham Lions and Hedgehogs charities, this event attracts thousands of visitors and includes live music, stalls and activities.

Picnic in the Park – a relaxed community event with a broad appeal that attracts over 1,000 visitors each year. Free live music and a selection of food and drink stalls.

Music in the Meadow – Every Sunday from end of May to early September. These series of 15 Sunday afternoon free music shows attract around 1,300 visitors per event

Allotment Show - Allotment holders show off their best produce in traditional fruit and vegetable competitions.

Remembrance Day – a parade through the town finishes in Gostrey Meadow and assembles around the war memorial for a service of remembrance.

Christmas lights switch-on – With Santa's grotto, nativity, children's activities, live music and stalls this event attracts several thousand visitors.

The Farnham In Bloom Volunteers run a minimum of six tasks within the Gostrey Meadow each year. The council actively encourages recognised groups to carry out volunteering annually like the

- Great British Spring Clean.
- RSPB Great Garden Bird Watch.

2.3.4 Sport and recreation

Sport offers a number of opportunities for the community and regular participation makes for healthier living which is a core priority for Farnham Town Council.

Gostrey Meadow is seen by the Town Council as a passive recreation and events space, with formal sports provision provided elsewhere in the town at sites like Farnham Park.

Farnham Town Council is currently consulting on the future use of Gostrey Meadow bowls green and Pavilion which closed in 2010. The green is currently cut for amenity purposes. Farnham Town Council have agreed to lease a section of land within Gostrey Meadow to the Ridgeway School for the provision of a community café.

Gostrey Meadow is also the staging post for larger community and active events in the town like the Farnham Walking Festival which takes place each year between May and June.

Farnham Town Council believes the key to developing active communities is making the opportunity wholly accessible to all residents for free. Community Festivals at Gostrey Meadow are a great place for local clubs and organisations to recruit new members.



Play at Gostrey Meadow

Play is an important part of the physical, emotional and psychological development of any child. In the urban environment, the park offers a far safer place for parents to take their children. Lack of garden space at home and the busy nature of most roads make 'community' play very difficult. Play within the park environment is not just about equipped

playgrounds; there are a host of other play-based activities.

Gostrey Meadow playground currently provides a Local Equipped Area for Play LEAP for the area providing play experience for both toddler and junior play.

Summer outdoor play days provide popular and engaging activities for parents/carers with young children.

Healthy living at Gostrey Meadow

The Farnham In Bloom volunteers along with the Town Council officers organise regular planting sessions in Gostrey Meadow and surrounding green spaces in the town.

The council will continue to support all activities in the park, which promote healthier living. Events supporting healthy activity will be given concessionary



2.3.5 Healthy living

Current concerns over increasing obesity nationally, the potential benefits of open spaces such as Gostrey Meadow are recognised more than ever.

The Farnham Walking Festival and regular Farnham In Bloom activities all make for great healthy pursuits and improve mental health and provide a great sense of community.

Farnham Town Council and the Farnham Community Enhancement Working Group work hard to provide a broad range of community activities for the whole family and the town council will continue to support all such activities in the park to promote healthier living.



2.4 MAKING THE PARK CLEAN, GREEN AND SAFE

2.4.1 Community safety

The Farnham Town Council Outside Works team has a permanent gardener presence on site at Gostrey Meadow five days per week and provides a uniformed presence.

Gostrey Meadow is covered by the Farnham Town Council town centre CCTV system. Live footage from the cameras can be monitored by Surrey Police staff from their control room in Guildford. The cameras help to provide reassurance to visitors and have resulted in the detection and prevention of crime.

2.4.2 Inappropriate behaviour

Anti-social behaviour by a minority of individuals can spoil everyone else's enjoyment of the Meadow.

Farnham Town Council staff, Police, PCSO and the Outside Works Team all work together towards a zero tolerance policy on vandalism and Anti-Social Behaviour.

Working with local Police and PCSO teams the Farnham Town Council Community Engagement Officer delivers citizenship programs with local schools to foster links with the park involving them in planting, maintenance and biodiversity. The Council also works with Police “**Designing Out Crime**” teams to ensure sight lines in the park are maintained and acts of vandalism and graffiti are dealt with rapidly.

2.4.3 Risk management

Public risk assessments:

In line with the Farnham Town Council's Health and Safety Policy (Appendix 5), site based risk assessments are undertaken regularly and were reviewed in 2020 after Farnham Town Council took over the management and maintenance of Gostrey Meadow at the end of 2019.

Farnham Town Council's Outside Works Teams undertake regular daily inspections of furniture and equipment on site to meet its duty of care under the Occupiers and Liability Act and Health and Safety at Work Act

Farnham Town Council also commissioned a recent condition survey of all its buildings, features and facilities in 2020 by a Chartered Surveyor with a priorities costed actions list for Gostrey Meadow.

Outside works team risk assessment

Farnham Town Council's Outside Works Team has a comprehensive list of Task Specific Risk Assessments and Safe Working Practices for all their activities taking place on site. These will be annually reviewed to ensure they are up to date and relevant in line with any changes in legislation.

All Site Specific aspects of the Meadow are examined and any high priority issues are assessed and addressed during the inspection.

Children's play areas

The existing LEAP Playground at Gostrey Meadow is inspected daily by Farnham Town Council Outside Works Team who are trained as ROSPA RPII Routine Daily Inspectors.

The monthly operational and annual ROSPA inspections are carried out by qualified contractors to ensure the Council is in full accordance with BSEN1176-1177.

2.4.4 Dog control orders

Under the Clean Neighbourhoods and Environment Act 2005 Dog Control Orders (DCO) give Borough Councils the power to make orders regarding dogs in the borough area.

Five offences prescribed in the DCO include:

- 1) Failing to remove dog faeces
- 2) Not keeping a dog on a lead
- 3) Not putting and keeping a dog on a lead when directed to do so by an authorised officer
- 4) Permitting a dog to enter land from which dogs are excluded
- 5) Taking more than a specified number of dogs onto land

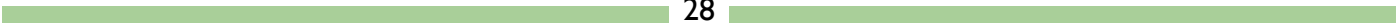
Borough Council has adopted the Dog Control Order as a more straightforward means of enforcement and to provide enforceable controls.

Borough council officers regularly inspect Gostrey Meadow and deal with any problems promptly.

2.4.5 Providing and maintaining a clean/safe environment

The Farnham Town Council Outside Works Team annual specification of works requires teams to maintain high standards based on an outcomes specification.

Emphasis is placed on complying with the EPA Environmental Protection Act code of practice for litter cleansing based on Gostrey Meadow having a Zone I classification as town park in close proximity to the town centre.

3.1 GENERIC MANAGEMENT

3.1.1 Leases and rights of passage

Current leases within the park

With the closure of the bowling green and pavilion in 2010, and the acquisition of the park by Farnham Town Council, its Assets Task Group has been looking for an alternative use. Farnham Town Council is in discussions with Ridgeway School which is a special school in Farnham about the possibility of leasing this area to them for the provision of a café. This idea is very much at the concept stage with no formal consultation started.

Farnham Town Council Outside Works Team currently

manages the green as amenity grass as bowls is not currently played on the Green.

Rights of Passage

Currently no rights of passage exist across Gostrey Meadow.

3.1.2 Sustainability issues

Gostrey Meadow has recently adopted standards in sustainable management which is part of the Farnham in Bloom campaign across Farnham which has been adopted on a number of sites across the town.

Since 2018, Farnham Town Council and the Farnham In Bloom Volunteers have experimented with a range of peat free growing mediums for town bedding displays.

Farnham Town Council Outside Works Team has a dedicated green waste composting facility within the town and recycle over 50% of the green waste generated from grounds maintenance operations across the Town.

All soil will be retained for re-use wherever possible including materials dredged from the River Wey.

When irrigation from natural water sources is required up to 20m³ per day can be pumped from the River Wey under license from the Environment Agency.

Herbicide will only be used in the case of pernicious weeds, alternative methods will always be used when appropriate.

3.1.3 Biodiversity and nature conservation

Farnham Town Council is working closely with Surrey County Council and the Farnham Biodiversity Group to develop a Biodiversity Action Plan for Farnham.

The Farnham Biodiversity Group (FBG) is a voluntary group whose aim is to draw up and put into practice a detailed Biodiversity Action Plan for Farnham. Biodiversity action plans are a proven way of addressing in a structured way the complex factors that affect ecosystems and wildlife habitats. They have been in use in the UK since the 1990s.

Farnham Town Council has committed to carrying out a Phase I Habitat Survey of Gostrey Meadow within the first two years of the Green Flag management plan for Gostrey Meadow to provide strategic direction for Biodiversity Management within the Meadow.

3.1.4 The Wey Landscape Partnership and Farnham Rivers Management Committee

Although Farnham Town Council does not have direct responsibility for any aspects of the town's river system, it recognises its duty on behalf of residents to ensure that flood risk management is receiving the attention it deserves.

The FRMC is made up of representatives of those with responsibility for or an interest in the river and drainage systems of the town. Members of the group include: The Environment Agency; Surrey County Council; Surrey County Council Highways; Waverley Borough Council; Farnham Town Council; Thames Water; The Farnham Society; Farnham Rivers Group; Residents' representatives.

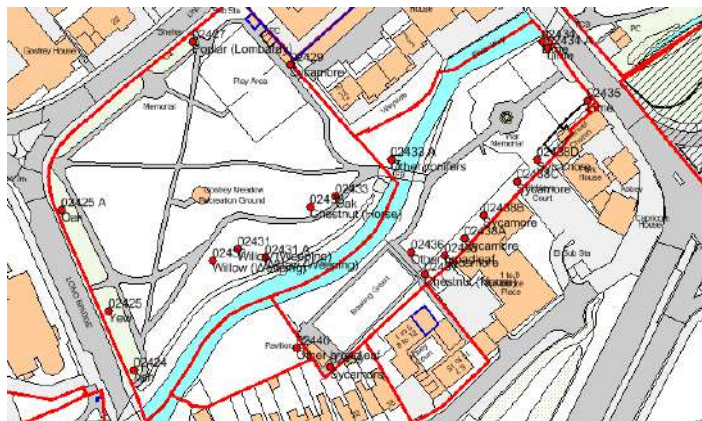
A number of bug hotels will be installed in Gostrey Meadow to encourage wildlife.



3.1.5 Tree management at Gostrey Meadow

Farnham Town Council manages the tree stock at Gostrey Meadow on a three year tree inspection cycle which is carried out by a local arboricultural specialist contractor.

There are currently 24 trees plotted at Gostrey Meadow and there will be 78 new trees and five specimen trees planted in early 2021 across Farnham and an old laurel hedge replaced by a Yew hedge around the War Memorial.

Farnham's Tree Trail is a self-guided circular tree trail of central Farnham which has been produced by Peter Bridgeman in partnership with Farnham Town Council. Eight trees mentioned in this trail are in Gostrey Meadow and include a Pocket Handkerchief Tree (*Davidia involucrata*), Lombardy Poplar (*Populus nigra* 'Italica') and Dawn Redwood (*Metasequoia glytostroboides*).

The contractors supply Farnham Town Council with a tree action plan and log any actions as High / Medium and Low risk.

3.1.6 Water quality and safety

The Environment Agency is the riparian owners of the river bed and Farnham Town Council is responsible for the vegetation management on the banks of the River Wey.

Public safety

Farnham Town Council Outside Works Teams undertake daily visual inspections to the playground as well as park facilities and furniture to meet its duty of care under the Occupiers Liability Act and Health and Safety at Work Act legislative duty.

Due to the width of the current path network on site there can be space sharing issues between pedestrians, cyclists and works vehicles.

Farnham Town Council branded maintenance vehicles use the existing footpath network, with hazard lights on and keeping to below 5mph.

3.2.2 General management throughout the park

The below sections outline all the key cleansing that takes place at Gostrey Meadow currently.

Dog fouling

Dog waste is collected as a dual waste stream along with the general litter in the standard park bins.

Borough Council staff are able to deliver fixed penalty notice to dog owners not paying heed to the Dog Control Orders introduced in 2019.

Litter and fly tipping

As a town centre park Gostrey Meadow is cleared under EPA Zone I Classification.

Occasionally fly tipping and graffiti occurs around some of the entrances to Gostrey Meadow and on equipment. This is dealt with by a responsive team and cleared within 24 hours of reporting.

3.2.3 Past management

Waverley Borough Council managed the park from 1974 to 2019. Gostrey Meadow as a key destination park close to the town centre has always had a high standard of traditional park maintenance with areas of formal bedding, seasonal displays including troughs, railing planters and carpet bedding.

As resources allow, the key focus areas like the War Memorial traditionally are the highest maintenance area within the park

3.2.4 Current public use

Gostrey Meadow, as the main town centre park for Farnham, has a high footfall both for commuters as well as active and passive usage.

Due to its central location Gostrey Meadow is also the main park used for community events.

Since the Gostrey Bowls Club ceased to play, the Gostrey bowls green specification has been reduced from Specialist sports turf to general amenity cut.

Linked to Farnham Town Council's long term patronage of the South & South East In Bloom campaign there has been a shift in focus towards more sustainable maintenance of Gostrey Meadow with conservation management practices being considered side by side with high horticulture standards.

There are currently six main access points to the park one via South Street four via Union Road and two via Long Bridge so the park is a busy thoroughfare during the week as well as popular open space for informal recreation.

The major areas of public use include:

- Junior and senior play area off Union Road.
- War Memorial off South Street.
- Central picnic area near the bandstand.
- Scenic walks along the River Wey with its more conservation focus.

Use of the park is largely during daylight but as Gostrey Meadow is a commuter route the town centre and Farnham Station the park has street lights and due to a new electricity supply the park is able to host evening events also.

3.2.5 Water Pollution

Due to the River Wey running through Gostrey Meadow no chemical control is used in proximity to the water course.

Farnham Town Council also works closely with the Environment Agency and South East Rivers Trust linked to Events management at Gostrey Meadow.

3.2.6 Public safety – play area

The play area currently complies with European Standard EN1176 and is inspected daily throughout the year by RPII trained inspectors; these checks are supplemented by an annual RPII Inspection.

3.2.7 Access and paths

Most of the paths at Gostrey Meadow follow the original layout of the park

Farnham Town Council is currently considering the existing widths of paths throughout the park and looking to create permeable grass crete paths either side of the existing path to expand the usable width of paths on site while maintaining permeability of surface.

The Bridge structure was inspected in 2020 and improvements to balustrades will be made when budgets allow.

3.2.8 Vegetation management

The vegetation across Gostrey Meadow is made up of three distinct vegetation zones which include:

Zone 1: High horticulture near War Memorial

Zone 2: Amenity horticulture within the central and perimeter vegetation

Zone 3: Conservation horticulture in proximity to the River Wey / Long Bridge end of the park

3.2.9 Railings and main entrances

The boundary wall around Gostrey Meadow is showing signs of decay.

Farnham Town Council has recently had the perimeter wall line and entrances surveyed by a civil engineer and have a costed improvement plan which will be submitted for CIL Funding in a phased programme of proactive building maintenance schedule.
